We take pride in our bagels and know you will be able to taste the passion.

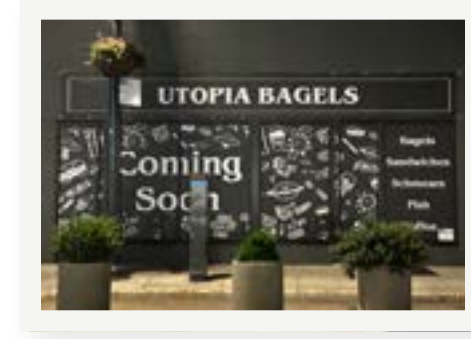

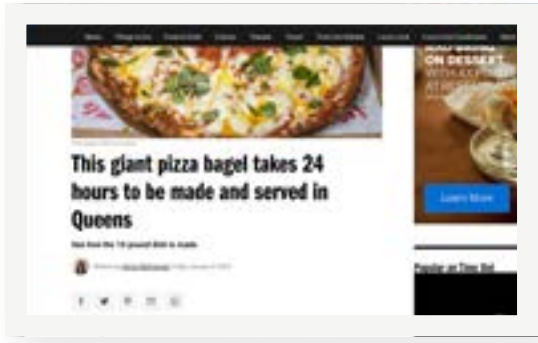
